## The Carlyle Group Announces First Quarter 2021 Financial Results

**Washington, DC, April 29, 2021** – Global investment firm The Carlyle Group Inc. (NASDAQ: CG) today reported its unaudited results for the first quarter ended March 31, 2021. Carlyle CEO Kewsong Lee said, "Excellent fund performance this quarter drove a record net accrued carry balance and we have strong momentum thanks to well-positioned investment portfolios and robust deal activity across our global platform. We believe our strong performance this quarter underscores how we'll continue to deliver value for our stakeholders as we execute on our long-term strategic plan."

U.S. GAAP results for Q1 2021 included income (loss) before provision for income taxes of \$1.2 billion and net income (loss) per common share of \$2.41 on a diluted basis. Total balance sheet assets were \$17 billion as of March 31, 2021.

### Dividend

The Board of Directors has declared a quarterly dividend of \$0.25 per common share to holders of record at the close of business on May 11, 2021, payable on May 19, 2021.
